

TERMS AND CONDITIONS FOR PARTICIPATION

1. For the Fall/Winter swim season, you have the option to pay the entire program fee at the time of registration, or to pay a deposit of 50% of the program fee at time of registration with the remaining balance (plus \$15.00 administrative fee) automatically charged to your card on file at the end of October 2015. For either payment option, \$150 of the program fee paid at registration is non-refundable. You are responsible for paying the balance due in full unless a medical refund was granted. For all other programs, program registration fees are due in full upon registration.
2. No refunds will be granted two weeks after practices have begun. Refund requests for medical reasons must be made via e-mail to the Board at LyonsSwimBoard@gmail.com. Phone and verbal requests will not be honored.
3. United States Swimming (USA Swimming) and/or U.S. Masters Swimming and/or USA Water Polo registration fees and/or Amateur Athletic Union (AAU) fees for diving are not refundable and must be paid prior to the swimmer/player entering the water.
4. When a swimmer is moved from one group to another, he/she must pay the fee for the highest group in which they participate, on a Pro-rated basis based on the time remaining in the current season.
5. Should a swimmer/player/diver decide to discontinue participation in the program with the Lyons Aquatics Club, any outstanding entry fees, for meets that they have entered regardless of whether they have actually competed, are considered an obligation to the Lyons Aquatics Club, and are payable upon termination of participation.
6. Swim meet entry fees will be billed throughout the course of the swim season and are payable within one week of receipt of bill(s). These fees include REGULAR SEASON, CONFERENCE, AND ALL CHAMPIONSHIP MEET ENTRIES - billed in December, February, and July.
7. Each swim family is responsible for a \$75 Administrative fee for the fall/winter season.
8. Each swimmer/player/diver and parent or guardian will be asked to agree to a "Code of Conduct" for participation in the Lyons Aquatics Club. Failure to comply with this code may result in the swimmer/player/diver being asked to leave the team.
9. Any checks returned to the Lyons Aquatics Club for non-sufficient funds will be subject to a \$25.00 additional handling charge.
10. Travel meet fees will apply for any Lyons Aquatics athlete participating in an away meet requiring an overnight stay. These fees help cover the travel costs for coaches and will be determined and communicated before the meet, and billed accordingly.

VOLUNTEER OBLIGATIONS

As a parent of Lyons Aquatics Club swimmer(s)/player(s), I understand that I have a duty to fulfill volunteer obligations at swim meets/tournaments sponsored by the Club. If you choose not to volunteer for these meets/tournaments, you must pay a \$200 opt-out fee per meet/tournament. If you do not show up for your volunteer assign water until this fee is paid.

At swim meets the format of the meet and number of sessions will dictate the volunteer obligation required by each family on the swim club. For the 2014-2015 season, the Club will host two swim meets on the following dates: October 17-18, 2015 and February 12-14, 2016. I understand that I may not be able to fulfill my volunteer duties in the session(s) in which my child(ren) compete(s). In the event I do not fulfill my volunteer obligations, I understand the Club will assess a penalty, and I agree to timely pay such penalty of \$200 per meet. I authorize the Club to charge my credit card on file with the Club for such penalty. I must volunteer for the current meet and cannot carry over my volunteer obligations to another meet or event.

At water polo tournaments you are expected to volunteer for one session per player, i.e. if you have two players in a tournament you are expected to volunteer for two sessions. I understand that I may not be able to fulfill my volunteer duties in the session(s) in which my child(ren) play(s). In the event I do not fulfill my volunteer obligations, I understand the Club will assess a penalty, and I agree to timely pay such penalty of \$200 per meet. I authorize the Club to charge my credit card on file with the Club for such penalty. I must volunteer for the current tournament and cannot carry over my volunteer obligations to another tournament or event.

INSURANCE WAIVER

I/We assume all risks and hazards of an incident to such participation and expressly hereby waive, release, absolve, indemnify and agree to hold harmless "Lyons Swim Club a/k/a Lyons Aquatics Club" and its officers, directors, employees, officials, sponsors, supervisors, other participants and any authorized persons transporting my/our son /daughter or self to or from activities, from any claim or cause of action arising out of injury to my/our son/daughter or self. It is the parent's responsibility to provide proper insurance for their son/daughter. I/We understand that this applies to any present or future injuries.

I/We agree to indemnify and hold harmless and defend "Lyons Township High School" including the Board of Education, its members, officers, agents, servants, independent contractors and employees from any and all claims arising from injuries, including death, damages and losses sustained by me or participant(s) and arising out of connected with or in any way connected with the activity of the program, not otherwise caused by the willful negligence of "Lyons Township High School."

I/We hereby authorize the staff of the Lyons Aquatics Club programs to act for me according to their best judgment in any emergency requiring medical attention. I know of no medical, mental or physical problem, which might affect my child's ability or myself from participating. I will be responsible for any medical or other charges in connection with his or her attendance. I hereby agree to save, indemnify and hold harmless the Lyons Aquatics Club staff, its agent's employees against any liability, claims or demands for damages arising from injuries sustained by my child or myself.

PHOTOGRAPHY WAIVER

Lyons Aquatics Club Photography Waiver:

I understand that I or my minor child may be photographed or videotaped while participating in these programs. I give permission for photos and/or videotape of my minor child to be used to promote the "Lyons Aquatics Club" and such photos and videos will be the property of "Lyons Aquatics Club".
